ARTICLE V


This corporation is to have a perpetual existence.

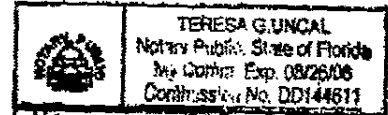
