# ARTICLES OF INCORPORATION OF BULL RIVER OUTFITTERS USA, INC.

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

## ARTICLE 1 NAME AND ADDRESS

The name of this corporation shall be BULL RIVER OUTFITTERS USA, INC. The principal business address of the corporation is 15841 Kilmarnock Drive, Fort Myers, FL 33912.

#### ARTICLE 2 DURATION

The corporation shall commence upon the filling of these Articles of Incorporation and shall have perpetual existence thereafter.
