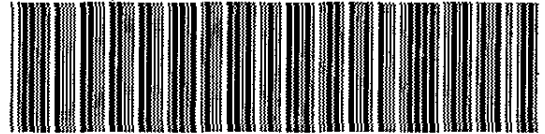

ARTICLE I - Name

The name of this corporation is JT'S INSTALLATIONS & MORE, INC.

ARTICLE II - Street Address and Mailing Address


ARTICLE IX - Indemnification




