ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - Name

The name of this Corporation is Totally Chiropractic, Inc. The principal place of business of this Corporation shall be 4710 Country Hills Drive, Tampa, Florida 33624 or such other place as may be designated by the Board of Directors.

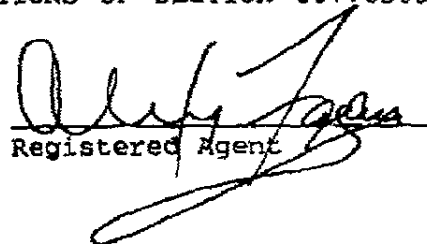
