OF

ARTICLE I. NAME

The name of this corporation is  
G. A. BURDETT, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.



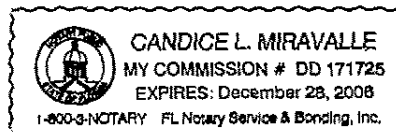


