The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit, under the laws of State of Florida.

**ARTICLE I. NAME**

The name of this Corporation is **CREEKSIDE MARINE CONSTRUCTION, INC.**

**ARTICLE II. NATURE OF BUSINESS**

The general character, purpose, and nature of the business is to construct docks, bulkheads and general marine construction, and any other lawful business in the State of Florida and elsewhere.

**ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock at a par value of \$1.00 per share.

**ARTICLE IV. TERM OF EXISTENCE**

This Corporation shall have perpetual existence.

**ARTICLE V. INITIAL PRINCIPAL OFFICE ADDRESS**


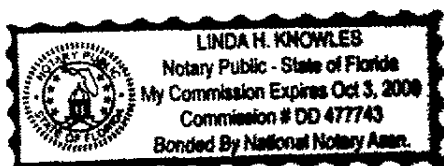
