**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Section 607.1006, Florida Statutes, **STOCKTON REAL ESTATE, INC.**, a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

1. The current name of this Corporation is Stockton Real Estate, Inc.
2. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

**ARTICLE I - NAME**


The name of the corporation (the "Corporation") is: **ESRE, Inc.**
