ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF ADVANTAGE CAPITAL EQUITY SOLUTIONS (FL), INC.

Pursuant to Section 607.1006 of the Florida Business Corporation Act, the undersigned on behalf and in the name of Advantage Capital Equity Solutions (FL), Inc., a Florida corporation (the "Corporation"), adopts these Articles of Amendment.

- 1. The name of the Corporation is Advantage Capital Equity Solutions (FL), Inc.
 - 2. Article II is replaced in its entirety to read as follows:

3. Article V is replaced in its entirety to read as follows:
