**ARTICLE VII: INCORPORATORS**



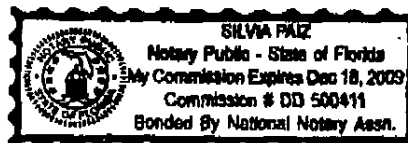
