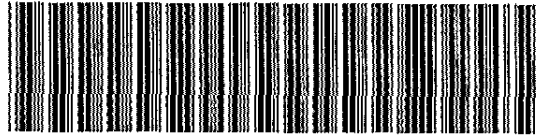

The undersigned subscriber to these Articles of Incorporation, is a natural person, competent to contract and hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is DAMI ALUMINUM, INC.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of this corporation is 18910 NW 51 Avenue, Miami Gardens, Fl 33055. The Board of Directors may, from time to time, designate such other address and place for the principal office of this corporation as it may see fit.

ARTICLE III - PURPOSE

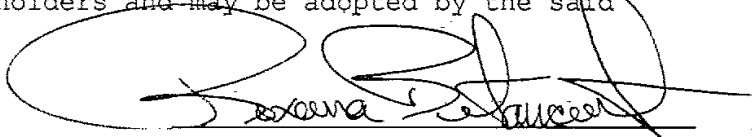

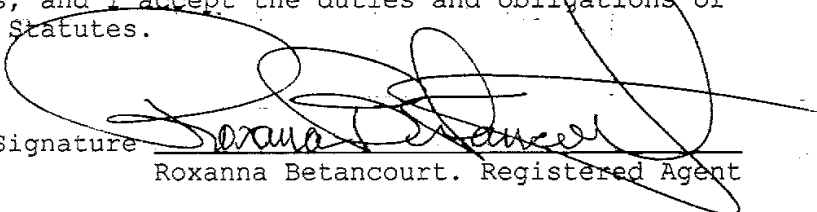
