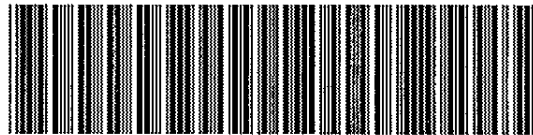

ARTICLE I - CORPORATE NAME

ARTICLE VII - AMENDMENT

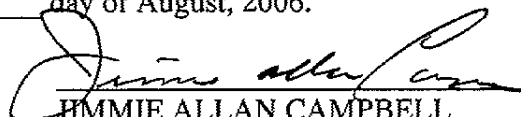
