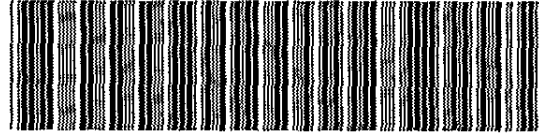

ARTICLES OF INCORPORATION  
OF  
REHAB IDEAS - WHEELCHAIR PRODUCTS AND ACCESSORIES, INC.

The undersigned, acting as Incorporator of a Florida corporation under the Florida Business Corporation Act, Chapter 607, Florida Statutes, hereby causes to be delivered the following Articles of Incorporation:

ARTICLE I


