The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

ARTICLE III: EXISTENCE AND DURATION

This corporation shall exist perpetually commencing on August 30, 2006.

ARTICLE IV: PURPOSE
