THE UNDERSIGNED, for the purposes of becoming a corporation the laws of the State of Florida has been a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, privileges, rights and immunities of a corporation for profit.

ARTICLE I

The name of the corporation shall be IONIX GAS TECHNOLOGIES, Inc.

ARTICLE II

The general character or nature of the business to be transacted by this corporation is to engage in any activity or business permitted under the laws of the United States and of this State.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding is 200 shares of common stock, each share having a par value of \$1.00. One hundred (100) shares shall be voting common stock and one hundred (100) shares shall be nonvoting common stock.

ARTICLE IV

The amount of capital with which this corporation shall begin business is \$200.00.
