ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is: Realty Mortgage of Miami, Inc.

ARTICLE II - DURATION

This corporation is to exist perpetually and it shall commence its existence as of the date of subscription and acknowledgment, provided such date is within five days from the date of fiting, otherwise, on the date of filing.
