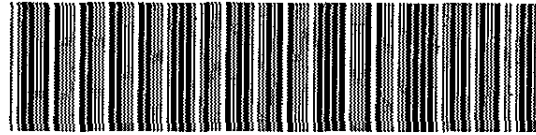

ARTICLE IX- PREEMPTIVE RIGHTS

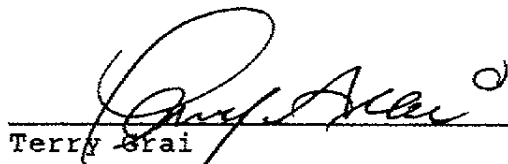
