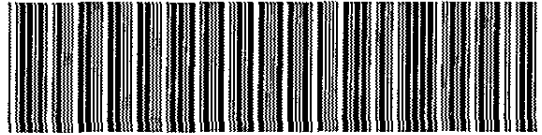



OF




