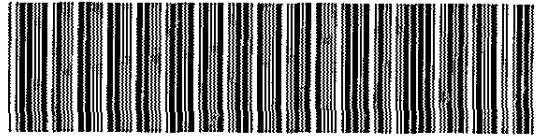

ARTICLES OF INCORPORATION

ARTICLE IV




