**ARTICLES OF AMENDMENT
OF
HUNTSVILLE BROADCAST CORPORATION**

The Articles of Incorporation of Huntsville Broadcast Corporation, a Florida corporation (the "Corporation"), incorporated on September 6, 2006, and assigned document number P06000115500, are hereby amended as follows:

A. By striking Article 3 of the Articles of Incorporation in its entirety and by substituting in its place the following:

3. Authorized Shares. The Corporation is authorized to issue 10,000 shares of common stock having a par value of \$.01 per share. No share shall be issued except upon payment to the Corporation of the par value of the share in cash or other consideration permitted by law as payment for shares.
