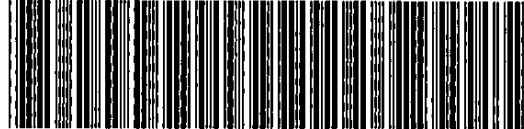

ARTICLES OF INCORPORATION

FOR

ARTICLE I - NAME

The name of this corporation shall be Yvonne Santiago M.D. P.A.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual.

ARTICLE III - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business under Chapter 607, Florida Statutes, as amended from time to time. The specific nature of business is the practice of medicine.

ARTICLE IV - AUTHORIZED STOCK

The corporation is authorized to issue One Hundred (100) shares of One Dollar (\$1.00) par value common stock.

ARTICLE XI - PRE-EMPTIVE RIGHTS

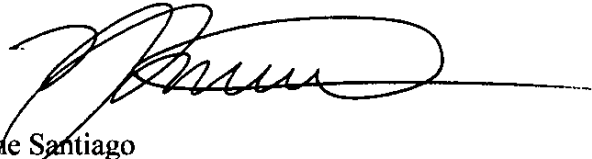

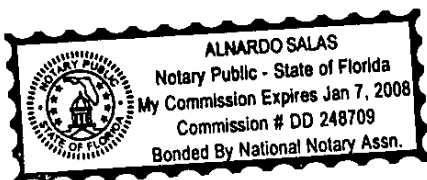
