The undersigned, acting as directors for the purpose of forming a corporation undersigned acting as directors for the purpose of forming a corporation undersigned, adopt the following Articles of Incorporation.

#### ARTICLE I

The name of the corporation shall be Florida Shores Bank - Southeast and its initial place of business shall be at 400 Federal Highway, Pompano Beach, Broward County, Florida 33062.

#### ARTICLE II

The general nature of the business to be transacted by this corporation shall be that of a general commercial banking business with all the rights, powers, and privileges granted and conferred by the Florida Financial Institutions Codes, regulating the organization, powers, and management of banking corporations.

#### ARTICLE III

The total number of shares authorized to be issued by the corporation shall be 3,000,000. Such shares shall be of a single class and shall have a par value of \$5.00 per share. The corporation shall begin business with at least \$6,500,000 in paid-in common capital stock to be divided into 1,300,000 shares. The amount of surplus with which the corporation will begin business will be not less than \$6,000,000.

#### ARTICLE IV

The term for which said corporation shall exist shall be perpetual unless terminated pursuant to the Florida Financial Institutions Codes.

#### ARTICLE V
