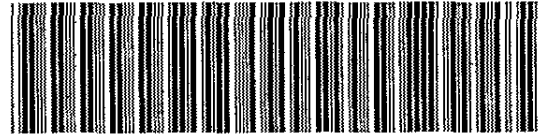

The name of the Corporation shall be:

VICTORIA TRUST TITLE, INC.

ARTICLE II

The Corporation is organized for the following purposes:

1. To engage in any activity within the purposes for which corporations may be organized under the Florida Corporation Act.
2. To provide title service to the people of the State of Florida.

4. 
