

(profit). If the option is available under laws of said state, the corporation elects to be treated and classified as a close corporation.

- 8. The corporation is authorized to issue one thousand (1000) shares of no par value, common stock, with identical rights and privileges the transfer of which is restricted according to the Bylaws. Preemptive rights to acquire additional shares are neither limited or denied. No shares have been issued. The total number of shares proposed to be initially issued is One Hundred (100), and the total consideration to be received for those shares is One Thousand Dollars (\$1,000.00).
- 9. The Corporation is organized for profit, with perpetual duration, beginning when these articles are filed. The corporation may engage in the transaction of any lawful business permitted by State Law with the primry purpose of the corporation being: MOTEL
