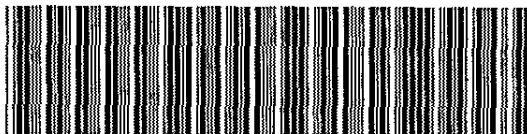

ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of TAMPA INDEPENDENT PARALEGALS, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

ARTICLE VI. COMMENCEMENT OF EXISTENCE

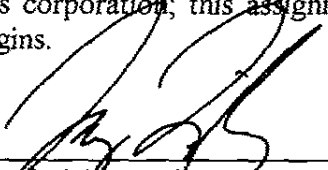
The existence of the corporation will commence at the time and on the date these Articles of Incorporation are filed with the Florida Department of State.
