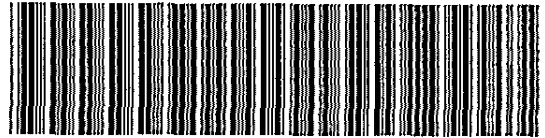

ARTICLES OF INCORPORATION

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Mary Zahner, Inc. and its principal place of business shall be located at 81 Round Rd., P.O. Box 611321, Rosemary Beach, FL 32461.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 2,000 (Two Thousand) shares of common stock of no par value, which shall be designated as "Common Shares."

ARTICLE X - INDEMNIFICATION




