

ARTICLES OF INCORPORATION

OF

ALTERNATIVE BUILDING CONSULTANTS, INC.

TALLAHASS OF, FLORIOA the corporation.

ARTICLE I NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation is Alternative Building Consultants, Inc., and its principal office shall be located at 302 Blackwood Place in the City of Longwood, County of Seminole, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places.

ARTICLE II **PURPOSES AND POWERS**

In addition to the powers authorized by the laws of the State of Florida for corporations, the general nature of the business or businesses to be transacted, and which the corporation is authorized to transact, shall be as follows:

- 1. To engage in any activity or business authorized under the Florida Statutes.
- 2. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Florida, and to do any and all things set forth in these Articles to the same extent as a natural person might or could do.
- 3. To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the business, good will, rights, assets, and liabilities of any person, firm, association carrying on any kind of business of a similar nature to that which this corporation is authorized to carry on, pursuant to the provisions of these Articles and to hold, utilize, and in any manner dispose of the rights and property so acquired;
- 4. To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.
- 5. To exercise all or any of corporate powers, and to carry out all or any of the purposes, enumerated in these Articles and otherwise granted or permitted by law. while acting as agent, nominee, or attorney-in-fact for any persons or corporations, and perform any service under contracts or otherwise for any person, entity, partnership, association, firm, syndicate, corporation, or other entity, and in this capacity or under this arrangement develop, improve, stabilize, strengthen, or extend the property and commercial interest of the property and to aid, assist, or participate in any lawful enterprise in connection with or incidental to the agency, representation, or service, and to render any other service or

assistance it may lawfully do under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of corporations for profit.

6. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.

The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this corporation, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.

Nothing contained in these Articles shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the corporation to carry on any business, exercise any power, or do any act which a corporation may not, under Florida laws, lawfully carry on, exercise, or do.

The corporation shall be organized as a subchapter S corporation of the Internal Revenue Code of 1986, as amended.

ARTICLE III EXERCISE OF POWERS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the officers of this corporation.

ARTICLE IV STOCK

The aggregate number of shares of stock which the corporation is authorized to issue is one thousand (1,000). Such shares shall be of a single class, and shall be without par value.

ARTICLE V DURATION

This corporation shall exist until dissolved in a manner provided by law.
