

ARTICLES OF INCORPORATION

OF

SCHWARZCO, INC.

The undersigned, acting as incorporator of SCHWARZCO, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is SCHWARZCO, INC.

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE
