





The undersigned incorporator to these Articles of Incorporation, a natural person Competent to contract, hereby forms a corporation under the laws of the state of Florida.

#### ARTICLE I

The name of this corporation is: FAY FR ENTERPRISES INC.

#### ARTICLE II

The general nature of the business to be transacted by this corporation is: To engage in any activity or business permitted under the laws of the United States And of this state.

To the same extent as natural persons might or could do, to purchase or otherwise Acquire, and to hold, own, maintain, work, develop, sell. Lease, exchange, hire, convey, Mortgage or otherwise to dispose of and deal in, lands and leaseholds, and any interest.

Estate, and rights in real property, and personal or mixed property, and franchises, Rights, licenses or privileges necessary, convenient appropriate for any of the purposes Herein expressed.
