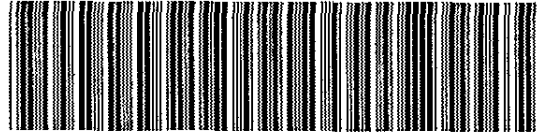

ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, Hereby adopts the following Articles of Incorporation:

ARTICLE I – NAME

The name of this corporation is MOOKEY'S BAR, GRILL & PACKAGE LIQUOR

ARTICLE II – PURPOSE

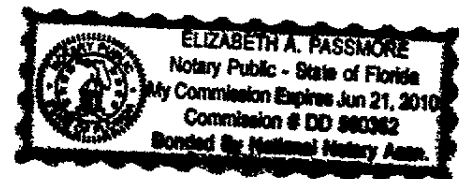
