The undersigned, in order to form a corporation for the purpose hereinafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows:

# ARTICLE I

## NAME

The name of this corporation is:

# ARTICLE II

#### PURPOSE

The general nature of the business to transacted by this corporation shall be:

A) To engage in any activities as a Real Estate Professional Association and other activities permitted under the laws of The United States and Florida.

B) To purchase, exchange, hire, or otherwise acquire such personal property, chattels, rights, easements, permits, privileges and franchises as may lawfully be purchased, exchanged, hired, or acquired. \_\_\_\_\_
