ARTICLES OF INCORPORATION

THE UNDERSIGNED, all of whom are duly licensed to practice veterinary medicine in the State of Florida, for the purpose of forming a professional corporation under Chapter 607 of the Florida Statutes, Florida General Corporation Act and Chapter 621, Florida Professional Service Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be:

Xocinit Michelle Bermudez, P.A.

ARTICLE II

The terms of existence of the corporation is perpetual, unless sooner dissolved in accordance with the Laws of the State of Florida. Corporate existence shall commence at the time of filling of the Articles by the Department of State, State of Florida.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to:

- a. To engage in every phase and aspect of the business of rendering the same professional services to the public that a realtor, duly licensed under the Laws if the State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the state of Florida therein.
- b. To invest the funds of this corporation in real estate, mortgages, stock, bonds or any other type of investment, and to own real estate and personal property necessary for rendering of professional services.

Capital Stock

The maximum number of shares of stock that this corporation is authorized to issue at any time is 100 shares of \$1.00 per value cach. None of the shares of this corporation may be issued to anyone other than an individual duly licensed to practice general medicine in the State of Florida.

ARTICLE VI

Principal Address

The principal office of this corporation shall be located at, 10500 SW 204 Terrace, Miami, Florida 33189, with the corporation retaining the power of moving its office to any other address in Florida, as may from time to time be determined and authorized by its Board of Directors, with branch office in such other cities, or countries as may from time to time be authorized by its Board of Directors.

ARTICLE VII

ARTICLE IX

The By-Luws of this corporation may be created, amended, changed or replaced by either the Stockholders or the Directors of the corporation at any duly scheduled Special Meeting called for that purpose.

ARTICLE X

Every person who now is or hereafter shall become a Director of this corporation, shall be indemnified by the corporation against all costs and expenses (including council fees) hereafter reasonably incurred by or imposed upon him in connection with, or resulting from any action, suit or proceedings, of whatever nature, to which he or she is or shall be made a part by reason of him or her being or having been a director of the corporation (whether or not he or she is made a party to such action, suit or proceeding, or at the time such cost or expense is incurred by or imposed upon him).

However, an exception is made to the above in relation to matters as to which he or she shall be finally adjudged in such action, suit or proceeding to have been derelict in the performance of the duties imposed in him as such Director. The right of indemnification between provided for shall not be exclusive of other rights to which any such person may now or hereafter be antitled as a matter of law.
