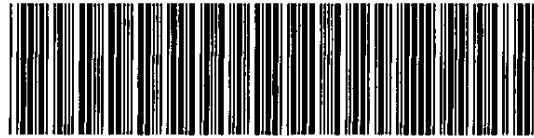


ARTICLE IX – BY-LAWS

ARTICLE X

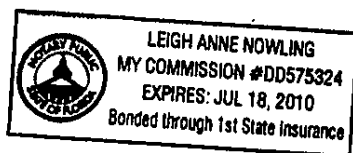


