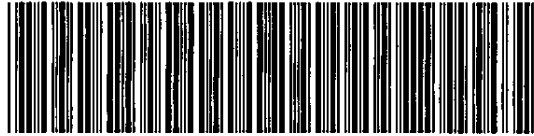

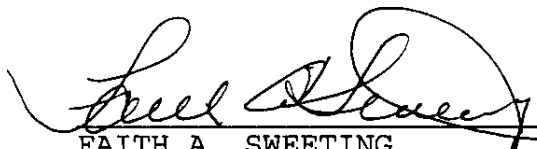
WILLIAM L. STEWART has resigned as Director, Shareholder and Registered Agent of the Corporation effective July 30, 2007.

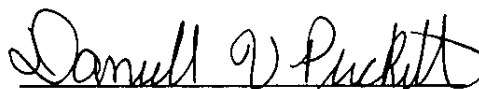
