We, the undersigned, do hereby associate ourselves together and subscribe
The Articles of Incorporation for the purpose of forming corporation under the Laws of the State
of Florida, Chapter 607 and subject to the following provisions:

ARTICLE ONE

The name of the Corporation shall be: MIAMI POWER PRODUCTIONS CORP.

ARTICLE TWO

This corporation shall have perpetual existence and may engage in any Activity or business
permitted under the laws of the United States of Florida

The general nature of business to be transacted by this corporation shall
Be:

- a) This Corporation is organized for the purpose of engaging in a business Organized under Florida General Corporation law, Chapter 607, Florida States.
- b) To manufacture, purchase or otherwise acquire, and to own mortgage, Pledge, sell, assign, transfer or otherwise dispose of, and it invest in, trade in, and deal in and with goods, wares, merchandise real and personal property, and services of every class, kind and description.
