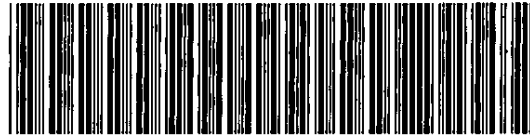

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is IYAH CURE MUSIC, INC. Its principal office address and business mailing address is 2393 South Congress Avenue Suite 200-42, West Palm Beach, Florida 33406.


