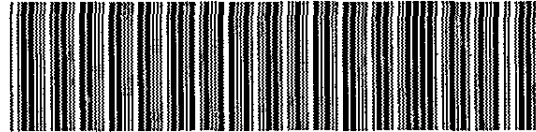

ARTICLE I - NAME

SECRETARY OF STATE

The name of this Corporation is MIAMI REMODELING & RESTORATION, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and mailing address is 5720 Southwest 11th Street, Miami, Florida 33144.

ARTICLE III - PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence on the date of filing these articles.

ARTICLE V - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such officer, director or committee member of this Corporation may be entitled.
