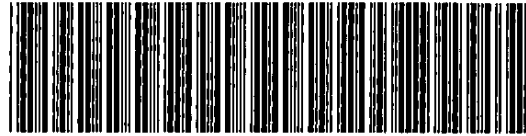

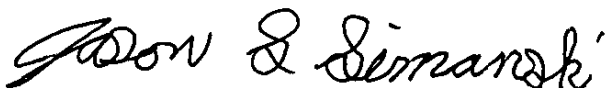

ARTICLES OF INCORPORATION
OF

The undersigned incorporation, for the purpose of forming a for profit corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I. NAME.

The name of the for profit corporation shall be Percision Underground Utilities, Inc.

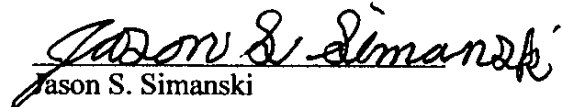
