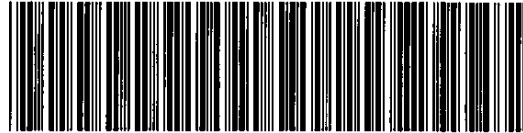

This Corporation is authorized to issue One Thousand (1,000) shares of common stock, no par value.






