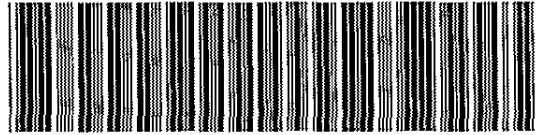

I

The name of the proposed corporation is :

This corporation shall have perpetual existence beginning on the date of incorporation.
