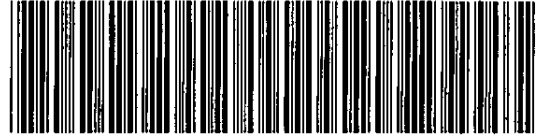


Subject: Dissolution of Corporation, S&S Exterior Services, Inc.
