

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Rightway Enterprises, Inc. Its principal office address and business mailing address is: 5071 South State Road 7, Suite 710, Davie, FL 33314.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE
