ARTICLES OF INCORPORATION OF

Kalish Equipment Corporation



The undersigned, acting as an Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - Name

The name of the corporation is: Kalish Equipment Corporation

ARTICLE II - Principal Office and Mailing Address
