ARTICLES OF INCORPORATION OF

SCORPIO DISCOUNT STORE INC.



ARTICLE I Name of Corporation

The name of this corporation is SCORPIO DISCOUNT STORE INC.

ARTICLE II Purpose

Organized primarily as a retail supplier of household goods and other accessories, SCORPIO DISCOUNT STORE INC. will, with the approval of its Board, transact any and all lawful business permitted under the laws of the United States and the State of Florida.
