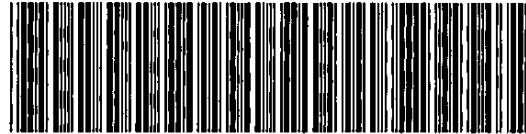

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is Pai Lum Family Arts Society, Inc. and its principal place of business shall be located at 1045 West International Speedway Blvd. Daytona Beach, FL 32114.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business regarding martial arts consulting.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 300 shares of common stock at \$1.00 par value, which shall be designated as "Common Shares."

ARTICLE V - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1870 Mason Avenue, Daytona Beach, FL 32117, and the name of the initial registered agent of this corporation at that address is Lyndon Shawn Dick.

ARTICLE VII - DIRECTORS

Initially, this corporation shall have 2 Directors who shall serve until his successors shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than two (2) directors constituting the initial Board of Directors.
