ARTICLES OF INCORPORATION OF BRICKELL AVIATION, INC.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is: BRICKELL AVIATION, INC.
