**ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is: **BRICKELL AVIATION, INC.**

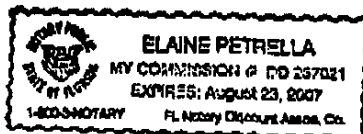
