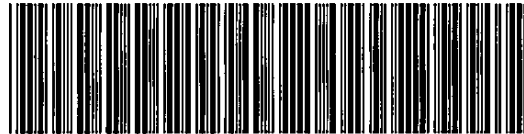

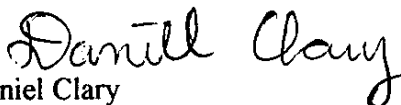

OF

The undersigned incorporator, for the purpose of forming A for Profit Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

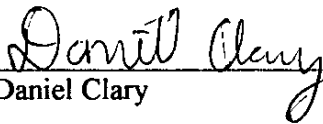

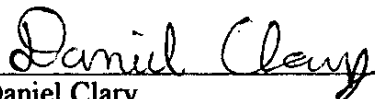
