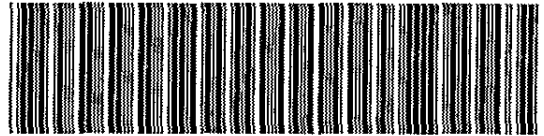



We, the undersigned, in compliance with Chapter 607 of the Florida Statutes, submit the following ARTICLES OF INCORPORATION for the purpose of forming a corporation for profit under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation is RICHARD A. FILSON, N.P., P.A.

**ARTICLE II**
