1. Introduction. Sean Piper, being duly sworn, deposes and says:

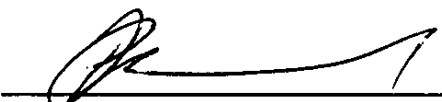

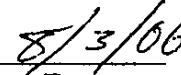

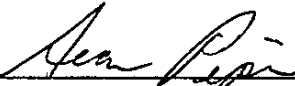
