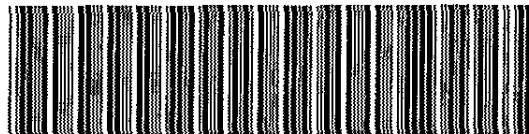

ARTICLE I - NAME

The name of this Corporation is **CENCOL CONTRACTORS, INC.** and the principal business address of the Corporation is **CENCOL CONTRACTORS, INC., 3400 Townsend Boulevard, Suite 139, Jacksonville, FL 32277.**

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the earlier of (i) the date of filing of the articles of incorporation or (ii) September 21, 2006 and shall be filed with the Secretary of State within five (5) business days from September 21, 2006. 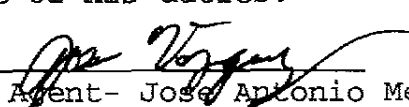
